PRE-EMPLOYMENT MEDICAL EXAMINATION (PEME) PROGRAM: NEWLY APPROVED CLINICS IN INDONESIA: MANDATORY APPLICATION OF PROGRAM FOR INDONESIAN SEAFARERS IN 2009

Your Managers are pleased to report the further development of the Club's PEME program. With effect from August 1, 2008, four clinics have been authorized in Indonesia. They are situated in Jakarta and Bali.

The PEME program is currently mandatory only for seafarers originating from Latvia, Poland, Romania, Russia and Ukraine. However, effective February 20, 2009, it will be mandatory for Members to utilize these clinics for Indonesian seafarers. Attached is the American Club-approved Medical Form which will be required to be completed for each seafarer's PEME. These forms will also be available for download on the Club's website. A reminder as to these details and the mandatory use of these clinics will be sent prior to renewal.
