### PORT STATE CONTROL: CONCENTRATED INSPECTION CAMPAIGN FOR ENTRY INTO ENCLOSED SPACES

The Paris and Tokyo MOUs on Port State Control have announced they will launch a joint concentrated inspection campaign (CIC) on crew familiarization with enclosed space entry. The CIC will run from September 1, 2015 to November 30, 2015.

The purpose of the campaign is to ensure ships have effective procedures and measures in place to safeguard seafarers when entering and working in enclosed spaces on board ship, and to check compliance with the applicable Safety of Life at Sea (SOLAS) Convention requirements.

During port state inspections, officers will check in detail the enclosed space entry procedures and measures that are in place. Port State Control Officers will use a questionnaire as attached to establish that crew members are familiar with the relevant equipment and have received training to identify and understand the hazards associated with enclosed space entry.

If a deficiency is found, actions by the port state may vary from recording a deficiency and instructing the master to rectify it within a certain period, to detaining the ship until the deficiency has been rectified. Any detention will be published in the Paris and Tokyo MOU monthly detention lists.

It is expected that approximately 10,000 inspections will be carried out during the CIC and the findings will be presented to the governing bodies of both MOUs for submission to the IMO for further consideration.

In this connection, and in amplification of the initiative described above, your Managers cannot overemphasize the risks the initiative seeks to address. Indeed, the Club recently had a case of multiple loss of life caused by entry into an enclosed space lacking adequate oxygen.

To this end, Members are referred to Club Circular No. 34/11, E-learning Tools: New Module on Entry Into Enclosed Spaces, The Case of the Silent Assassin and Club Circular No. 11/13, E-learning Tools: New Module on Entry Into Enclosed Spaces: the <u>Case of the Invisible Assassin</u>, highlighting risks of entry into enclosed spaces. 
