PRE-EMPLOYMENT MEDICAL EXAMINATION (PEME) PROGRAM: CLINICS APPROVED FOR TRANSITING SEAFARERS FROM LATVIA, THE PHILIPPINES, POLAND, ROMANIA, RUSSIAN FEDERATION AND UKRAINE

Your Managers are pleased to announce the development of new capabilities in the provision of service under its PEME program. They are described below.

## Approval of clinics for crew in transit

In response to Members' requests, your Managers have taken steps to extend the Club's PEME program to include clinics in locations outside the home countries of seafarers requiring such examinations, that is to say seafarers originating from Latvia, the Philippines, Poland, Romania, the Russian Federation and Ukraine.

Members are asked to note that Club medical forms are valid for one (1) year in the case of seafarers needing them. Through the expansion of the Club's PEME clinic network around the world, Members will be able to have PEMEs performed without having the seafarer sent home to his native country.

Members should be aware that if they wish to utilize a clinic outside the seafarer's native country, the Managers must be notified in advance to assist in facilitating the PEME at the appropriate location.

The first of these clinics have been approved in the United States and are listed below. It is expected that, by April 2008, clinics in Antwerp, Rotterdam, Shanghai, Singapore, Hong Kong, Athens and Istanbul will also have been approved. Members will be notified about these clinics as they are authorized.
