PRE-EMPLOYMENT MEDICAL EXAMINATION (PEME) PROGRAM: NEWLY APPROVED CLINICS IN MURMANSK AND KALININGRAD, RUSSIAN FEDERATION

Your Managers are pleased to announce the approval of clinics in Murmansk and Kaliningrad, Russian Federation, in further development of the Club's PEME program. The Club now has a total of 25 approved clinics in Latvia, the Philippines, Poland, Romania, the Russian Federation and Ukraine. Members are reminded that as of February 20, 2007 seafarers from these countries will be required to have their PEME conducted at one of those approved clinics.

It also expected that additional clinics in Sevastopol, Ukraine and Novorossiysk, Russian Federation will be approved prior to February 20, 2007. Contact information for the clinics on the point of approval in Sevastopol and Novorossiysk will be forwarded as soon as the process has been completed.
