This application notes that it is a condition of the confirmations requested of the Insured's P & I Club that neither the information confirmed, nor the fact that the above named Member is a Member of this Association and may be covered for certain passenger liability risks, shall form part of any application to any Flag State Authority or any other governmental agency or be used in support of any application for the purposes of demonstrating evidence of insurance or evidence of compulsory insurance under any applicable law relating to liability for the death of and personal injury to passengers.
